If you agree to this Agreement on behalf of a business, you represent and warrant that you have authority to bind that business to this Agreement, and references to "You" and "Your" herein refer to that business. By signing below, You agree to the terms and conditions of this Agreement. This agreement governs your participation in Lansweeper's user participation program ("Program") which allows You to contribute to the development of features and functionalities of the Lansweeper Product by participating in Lansweeper user experience research activities, surveys, evaluation of preview and/or beta releases, and/or any other activities in which You will provide information about your user experience to Lansweeper.

Participation in the Program requires that you have purchased a subscription to the Lansweeper Product and that you have entered into Lansweeper's Terms of Use, provided under the following URL: https://www.lansweeper.com/terms-of-use/ (hereinafter "ToU").

By signing below, You accept and acknowledge the following terms and conditions:

- Beta and Preview Releases. Participation in the Program may entail or even require that You make use of Beta and/or Preview Releases (as provided in the ToU) of the Lansweeper Product. Beta and Preview Releases are for evaluation purposes only and may contain errors, fail, return inaccurate results, and/or be subject to other malfunctions. Lansweeper does not guarantee that Beta and Preview Releases will be commercially released and Lansweeper may change the Beta and Preview Release or terminate the use thereof at any time without prior notice. Use of Beta and Preview Releases is at Your own risk and Lansweeper shall not be liable for any damages resulting from Your use thereof.
- Proprietary & Confidential.
